# INQUEST INTO DEATH OF PITR TSCHIKOVO & SAMYUEL NEJEM-LI

Findings of: Coroner Christos Stefanidis

Deceased: Pitr Tschikovo, Samyuel Nejem-Li

Date of birth: 1/3/918, 18/8/916

Date of death: 5/6/939

Cause of death: ONTOPHAGY SYNDROME RELATED COMPLICATIONS, BLUNT FORCE  ${\bf TRAUMA}$ 

Place of death: 301/1 Chowaka Lane, CH, Littoria

Sam tiptoed over to the bed where the sick man was dreamlessly sleeping. He lent over the headboard, and gently examined Pitr's features. He was still losing weight, his face had lost its delightful fullness to reveal a new more papery gaunt one underneath. Sam gently ruffled Pitr's hair,

"You hungry?"

Pitr stirred, not opening his eyes but groaning slightly at the interruption. He was silent for a few seconds. "Yeah."

"What do you want?"

Pitr grimaced with the effort of thought. He stayed like that, eyes squinted shut. "Pasta. Carbonara."

Sam was very happy with that answer, happy that Pitr had finally asked for something fatty and energy dense. He gently placed a kiss on Pitr's colourless lips. "I'll be back in a bit."

- 8. Due to the state of the body, visual identification by family members was not possible. Identity was established through scene investigation and dental records.
- 9. Identity is not in dispute.

### MEDICAL CAUSE OF DEATH

- 10. Forensic Pathologist Dr Judith Han and Forensic Ontologist Dr Malinda Ruby from the Chasei Institute of Medicine conducted an examination of the body on 7/6/939.
- 11. Toxicological analysis identified Yodheyvir, Baelisib, and Sandalphoxacin in the deceased's body, all typical drugs prescribed to treat acute ontophagy syndrome, as well as high doses Ibuprofen and Paracetamol.
- 12. Dr Han and Dr Ruby provided the opinion that the medical cause of death was ontophagy syndrome related complications exacerbated by overdose of Yodheyvir and Sandalphoxacin, as well as blunt force trauma.
- 13. I accept Dr Han and Dr Ruby's opinion.

### CIRCUMSTANCES IN WHICH THE DEATH OCCURRED

- 14. At the time of death Mr Pitr Tschikovo (21) and Mr Samyuel Nejem-Li (22), were at their shared apartment. Mr Tschikovo had been at home for the previous 13 days due to symptoms caused by his chronic Dysmagia and Ontophagy Syndrome.
- 15. Mr Tschikovo underwent a rapid deterioration of his condition, at some point leaving his bedroom and entering their shared lounge room. Neither the police nor medical services were ever contacted by either Mr Nejem-Li or Mr Tschikovo.

Pitr's forehead cracked, and fell inward, shards of skin and bone falling down into the eigengrau chasm revealed beneath. The colour of his body splashed through the floor, leaving a monochrome man standing slightly wrong in the carpet. His flesh spewed and took in colours, it melted and recombined, and screamed all around Sam with no noise.

19. At some point in the altercation, Mr Tschikovo sustained blunt force trauma to the frontal lobe. It is hypothesised by the Coroners Court that this injury was inflicted by Mr. Nejem-Li, though exact means cannot be established by medical examination.

20. Mr Tschikovo's head injury likely caused his body to rapidly decohere as a result of his acute ontophagy syndrome.

"Are we dead?" Sam asked Pitr, who was above and below him, within and without.

"Not yet." He replied, but he did not say it.

"Damn."

25. The southwestern corner of the third and fourth floor demanifested.

"Are you feeling better?" Sam asked Pitr and Pitr asked Sam

"I have no body now, so yes."

The eigengrau contracted and expanded with each chuckle.

"This isn't so bad."

The inside of their minds hummed in agreement.

"I can think of worse ways to die."

30. First responders arrived at the scene at 5:45pm after a partial evacuation 301/1 Chowaka Lane. Paramedics and firefighters report feeling extreme nausea and disorientation while present at the apartment complex.

31. First responders discovered the bodies of Mr Tschikovo and Mr Nejem-Li floating in the cavity between the third and fourth floors. They report they saw the two bodies melded together, with no obvious trauma associated with forceful physiological amalgamation. The physical structure of the bodies was not consistent with baseline reality.

An overtall woman in medical scrubs, with the appearance of someone who was desperately hungry, looked over the object on the examination table. Another woman, shorter and more wiry, covered with all manner of protective amulets, tattoos, and rings, suppressed the urge to vomit. They both beheld the thing that was two bodies in amalgam. Too many limbs, too few of them discernible. Unrecognisable corners and bulges and organs. One could only tell it was meant to be two people because of the line dividing two skin tones that ran along the outside of the object.

Dr. Ruby looked to Dr. Han. "Where do we even begin?"

#### FINDINGS AND CONCLUSION

44. Pursuant to the Coroners Act (925), I make the following findings:

44a. This incident shows the danger that Ontophagy syndrome poses both to individuals, and to society as a whole. More must be done to reduce the risk Ontophagyacs pose to public safety.

- 44b. Despite my suspicion that foul play was involved, the Coroners Court has made a special decision to treat the two deaths as a single case, due to their physiological amalgamation.
- 45. Pitr Tschikovo and Samyuel Nejem-Li died on 5/6/939 due to ontophagy syndrome related complications and blunt force trauma.

46. I extend my condolences to the family of Mr Nejem-Li and all those involved in the incident.
